



## Rules and Requirements

**ELIGIBILITY:** The 2025 JourneyForth Summer Reading Challenge is open only to legal residents of the fifty (50) U.S. states and the District of Columbia. Parents or guardians who are 21 years of age or older may enroll their child(ren), ages 4-17, in the reading challenge. Any entries not eligible for any reason will be disqualified from winning the prize(s). Children of BJU Press employees are not eligible to enter prize drawings but will receive the completion prize for their age group. Void where prohibited by law. All applicable federal, state, and local laws apply.

**HOW TO ENTER:** Beginning June 1, 2025 through August 19, 2025, parents/guardians may sign up their children at [bjupresshomeschool.com/summer-reading](http://bjupresshomeschool.com/summer-reading). To be eligible for prizes, participants must read or be read to for 15 minutes per day for 40 days between June 1, 2025 and August 19, 2025; days do not need to be consecutive. No purchase necessary. Upon completion of the reading requirement, parents/guardians must submit the challenge completion form on or before August 19, 2025 in order for their students to receive a completion prize and to be eligible for the prize drawings. Limit one (1) entry per drawing per participant.

**PRIZE AND ODDS:** While supplies last, students who complete the JourneyForth 2025 Summer Reading Challenge will receive a small prize based on their age group (ages 4-8, ages 9-12, ages 13-17). Five (5) weekly prize winners will be chosen at random from the pool of completion form submissions on July 17, July 24, July 31, August 7, and August 14, 2025. Each weekly winner will receive one (1) JourneyForth title (\$7-9 value). Within each age group, three (3) grand prize winners will be chosen at random on August 21, 2025. The grand prize winners will receive one (1) tote bag and five (5) JourneyForth novels (\$50 value). All prize details are at the sole discretion of BJU Press. The odds of winning will depend upon the number of eligible entries received.

**RANDOM DRAWING WINNER NOTIFICATION:** Winners for the weekly book drawings and the grand prize drawing will be notified by email. If necessary, alternate potential winner(s) may be selected by random drawing from among all remaining eligible entrants. Winners' first names and last initials will also be announced on JourneyForth's social media pages.
